You Qualify If You:

- Are an active Union Gas customer with an existing natural gas furnace/boiler as your main heat source.
 - Own a detached, semi-detached, row town house, or mobile home.
 - Do an energy assessment both before and after your renovation.
 - Complete at least two eligible energy upgrade renovations.
 - Maximum of 120 days between 1st and 2nd assessment allowed.
 - Provide copies of all receipts for energy upgrades.
- ★ Maximum \$5000 rebate includes a \$550 rebate for both energy assessments. Customer pays the HST.

Bonus Rebates

- \$250** For completing 3 energy upgrades
- \$500** For completing 4 energy upgrades
- \$750** For completing 5 energy upgrades
- \$1000** For completing 6 energy upgrades and so on

- (1) This rebate is pro-rated based on the percentage of wall area insulated and does not include walls between individual units. For a semi-detached, rebates are 75 percent of the amounts shown.
- (2) When both a basement and crawl space are present, all applicable grants are pro-rated to a maximum of \$1,250 based on the total wall area.
- (3) Can qualify for either crawl space wall or floor above crawl space rebate.
- (4) 100% ceiling coverage required upon completion. When the roof consists of more than one type (i.e., attic, cathedral ceiling and flat roof), rebates are pro-rated based on ceiling area and roof type. The rebate for any combination of attic, cathedral ceiling and flat roof cannot exceed \$500.
- (5) Maximum one water heater rebate per home.
- (6) \$40 rebate per rough opening. Bay windows considered one rough opening.
- (7) A combi or combo system CANNOT qualify for both the space heating boiler rebate and the domestic hot water rebate; it counts as one measure.
- (8) Electric water heater does not qualify for rebate.

BASEMENT INSULATION

- \$1000** For adding at least R23 to 100% of basement
- \$500** For adding at least R12 to 100% of basement

CRAWL SPACE INSULATION

- \$800** For adding at least R23 to 100% of crawl space wall
- \$400** For adding at least R10 to 100% of crawl space wall
- \$450** For adding at least R24 to 100% of floor above crawl space

EXTERIOR WALL INSULATION

- \$1500** For adding at least R9 to 100% of building to achieve a minimum or R12
- \$1000** For adding at least R3.8 to 100% of building to achieve a minimum or R12

WATER HEATER

- \$200** For replacing your water heater with an ENERGY STAR® 0.80EF or higher tanked natural gas water heater.
For replacing your water heater with an ENERGY STAR® 0.82EF or higher tankless natural gas water heater.

WINDOWS / DOOR / SKYLIGHT

- \$40** For each window, door or skylight replaced with ENERGY STAR® qualified model.

ATTIC INSULATION

- \$500** For increasing attic insulation to at least R50 from R12 or less
- \$250** For increasing attic insulation to at least R50 from R13 to R25
- \$500** For increasing cathedral/flat roof insulation by at least R14

AIR SEALING

- \$150** For achieving 10% or more above base target
- \$100** For achieving base target

FURNACE/BOILER**

- \$750** For replacing a 94% or less AFUE natural gas furnace with a 95% or higher condensing natural gas furnace. For replacing a 89% or less AFUE natural gas boiler with a 90% or higher condensing natural gas boiler.

*The combi system qualifies as a boiler and is eligible for the rebate.
 **Furnace/Boiler rebate is only applicable to UG customers with existing furnace/boiler as primary heating source.
